

# Additional Agreement Personal Account

Date: March 16<sup>th</sup>, 2008

Update: October 02<sup>th</sup>, 2021

## 1 Subject

- i. The user receives a personal account on the web site [www.xlog.ch](http://www.xlog.ch). The provider XLOG Technologies AG allows the user:
  - To receive news.
  - To create topics and comments.
  - To purchase products and licenses.
- ii. The web site terms of use form an integral part of this agreement.
- iii. The conditions products & licenses form an integral part of this agreement

## 2 Duration and Termination

- i. The personal account is granted after registration over the website [www.xlog.ch](http://www.xlog.ch), the choice of a nick name and optionally of a homepage, as well as the recognition of the e-mail address of the user.
- ii. The provider reserves the right to cancel the services of the web site or to lock the personal account of user without a warning at any time.
- iii. The provider disclaims liability for an e-mail address that was falsely confirmed by a user.

## 3 News

- i. News is sent when the user has chosen the option in his personal account and

when the user has confirmed his e-mail address.

- ii. The user can uncheck the option any time. Each sent news includes a hint how to uncheck.

## 4 Topics and Comments

- i. The own topics and comments are shown, as well as the foreign authorized topics and comments.
- ii. Own topics and comments can be deleted at any time. If a topic is deleted all related own and foreign comments are deleted as well.
- iii. The provider reserves the right to not authorize a topic or comment without a warning at any time. Only authorized comments and topics are seen by foreign users.
- iv. Topics and comments show the nick name of the user and optionally the homepage, but not the e-mail address. The nick name of the user and optionally the home page can be changed at any time. Changes are immediately reflected in all topics and comments of the user.
- v. The dissemination of authorized topics and comments is regulated in the web site terms of use. By this agreement the user accepts the terms dissemination.

## 5 Products and Licenses

- i. The personal account permits the access to the sales system. XLOG Technologies AG reserves the right to change functions of the sales system at any time.
- ii. The personal account does not permit resale or a commercial use of the access to the sales system.
- iii. All industrial property rights regarding the functions - copyright and patent rights in particular - are the sole property of XLOG Technologies AG.
